

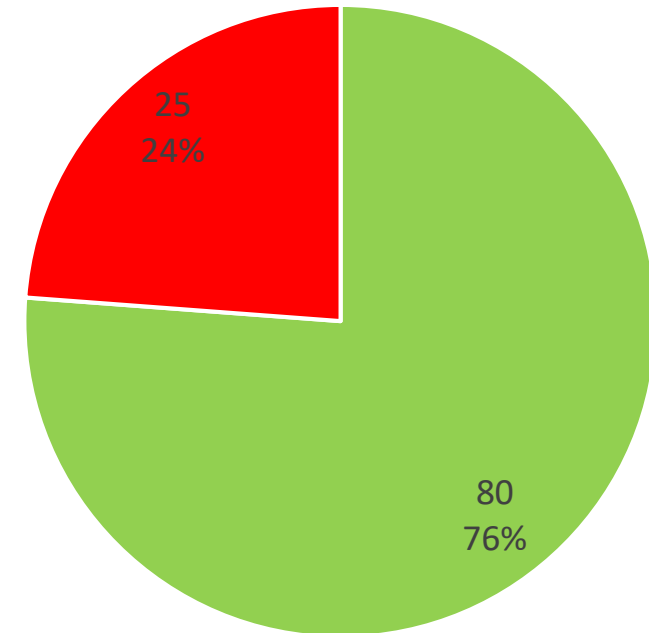

■ States Parties that should have submitted an IR and DID NOT

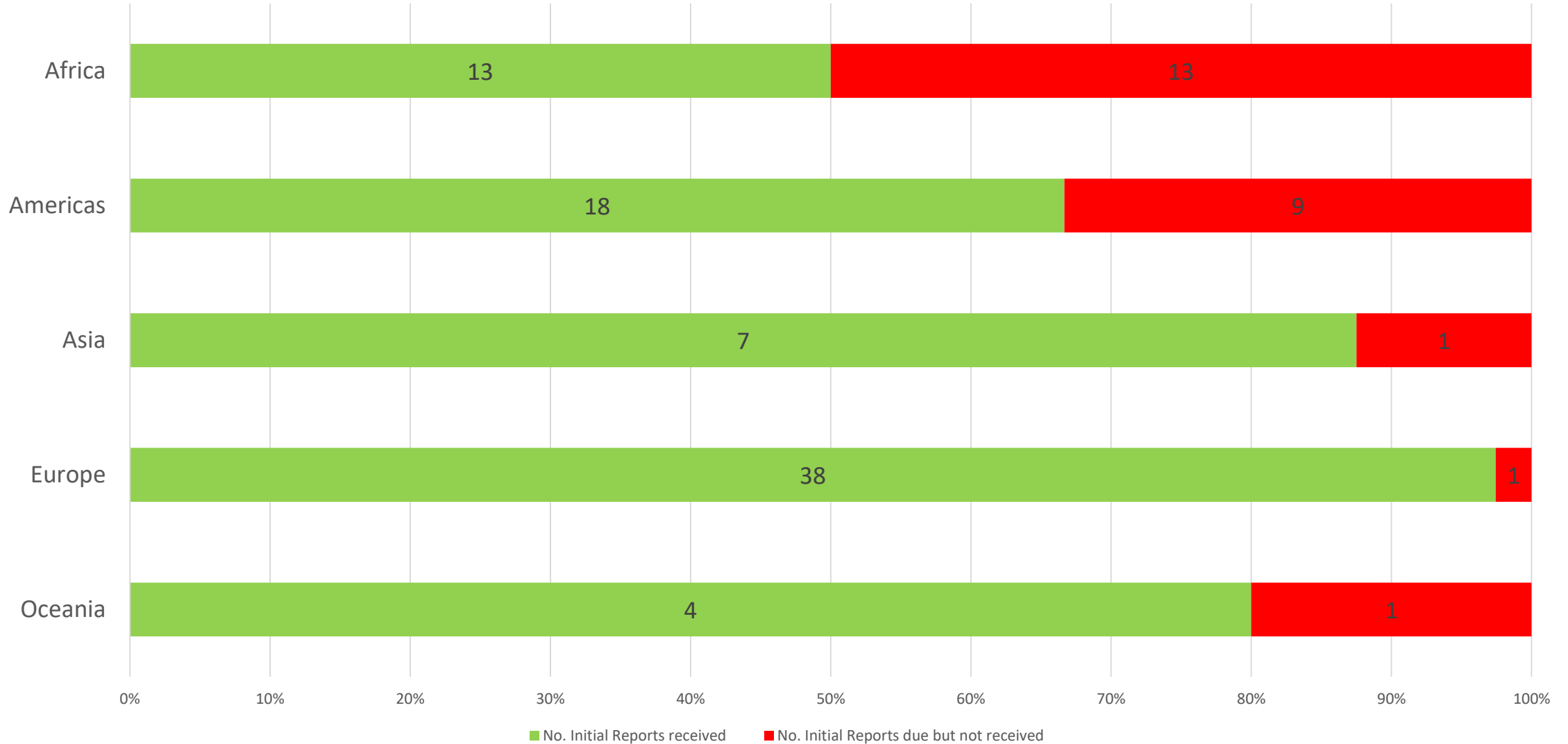

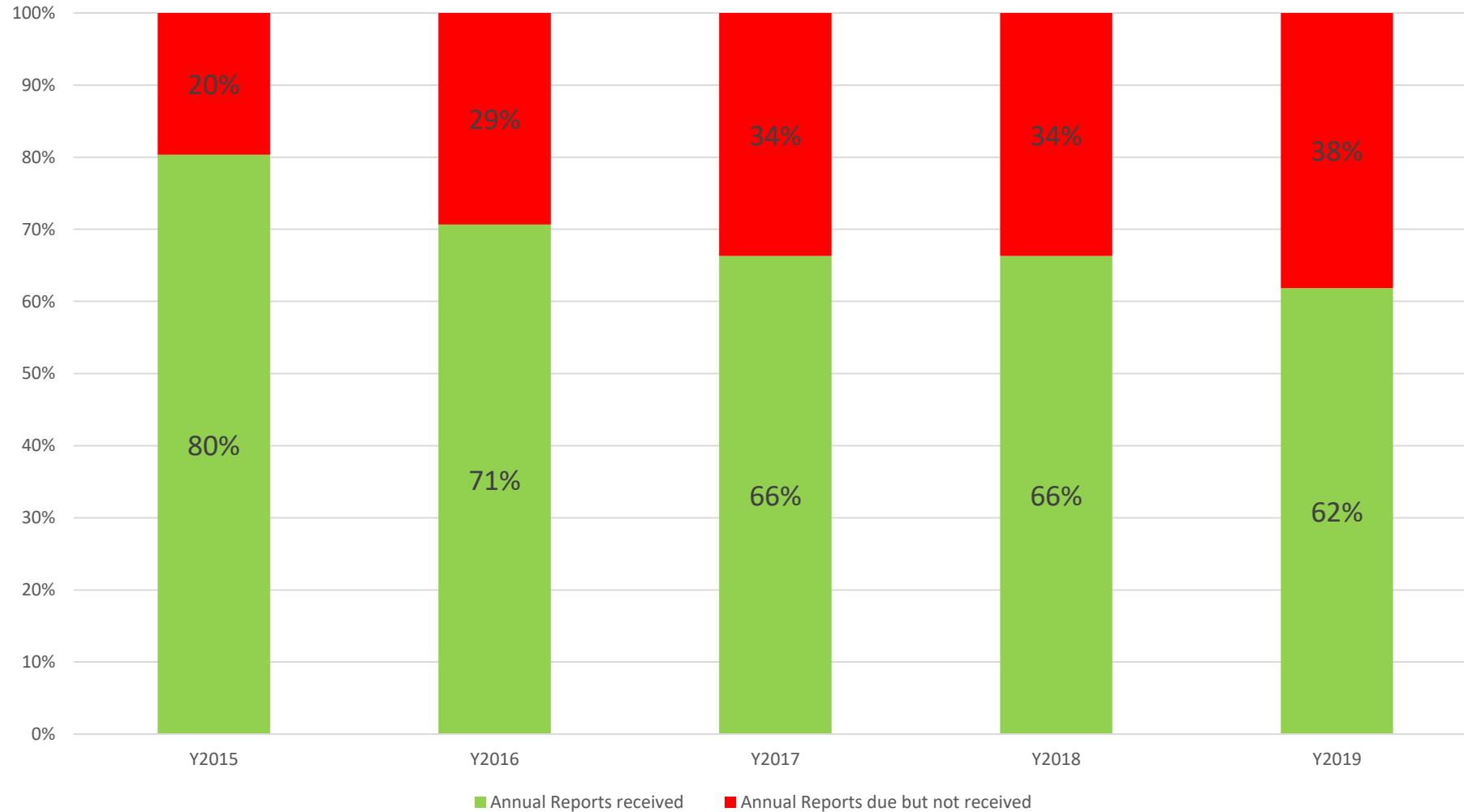

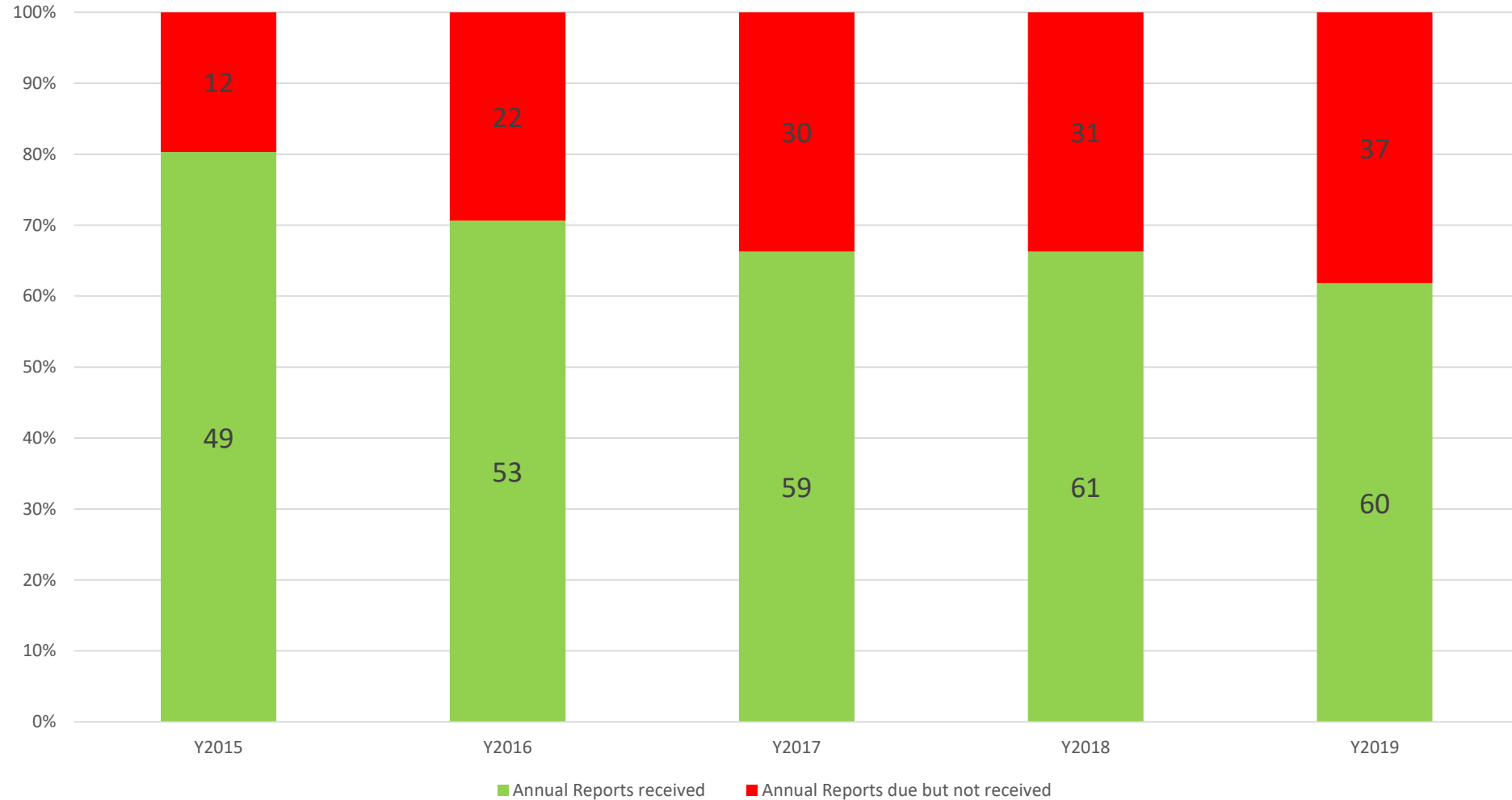
Annual reports 2015-2019

Global statistics (by %)



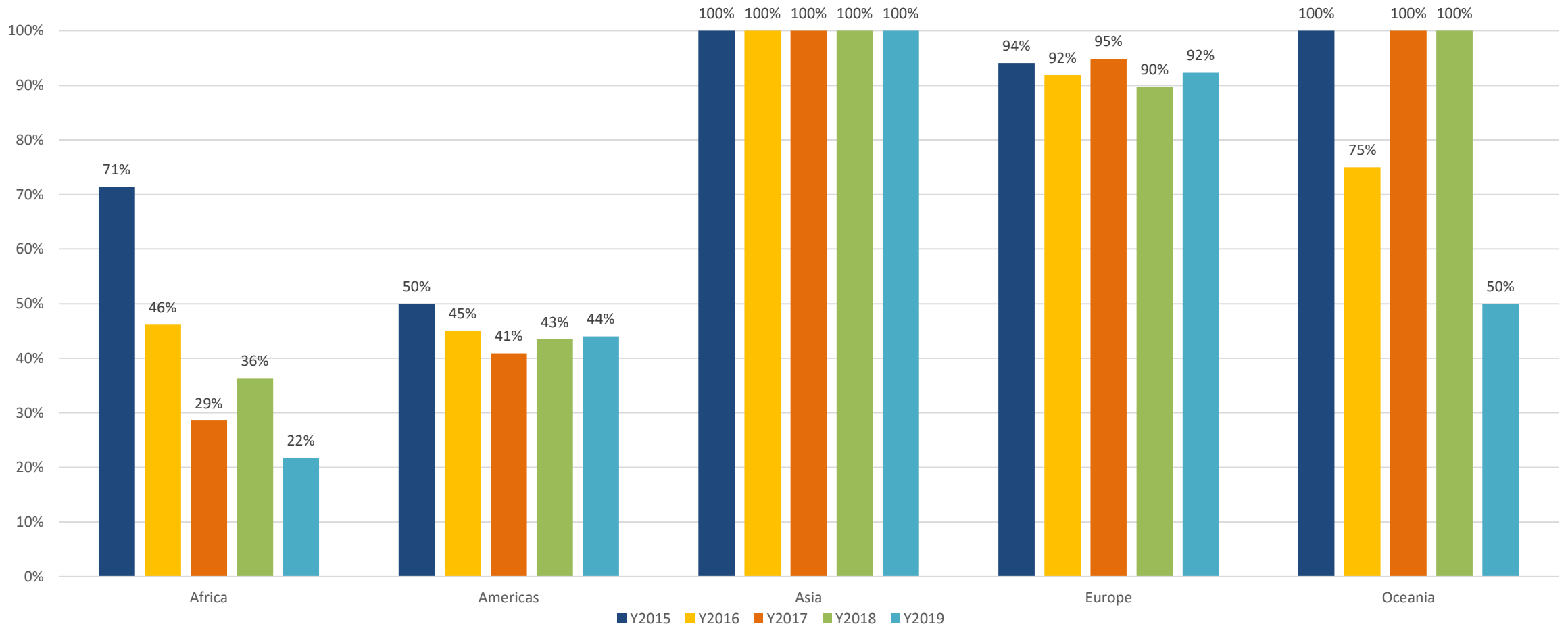
Annual reports 2015-2019
