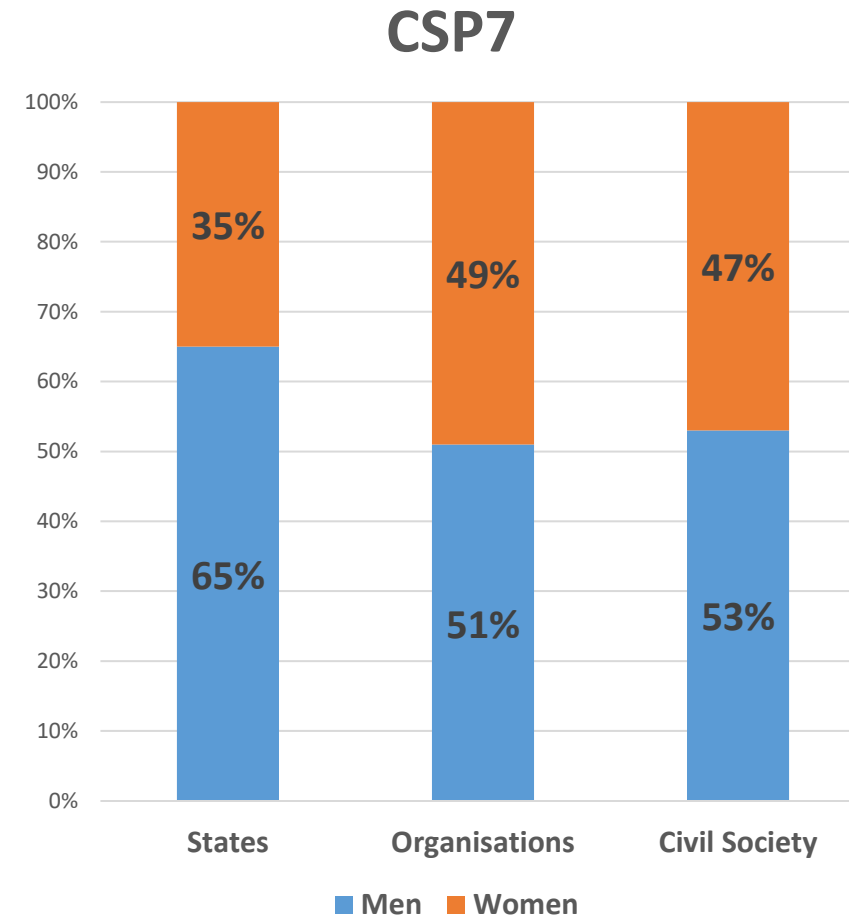
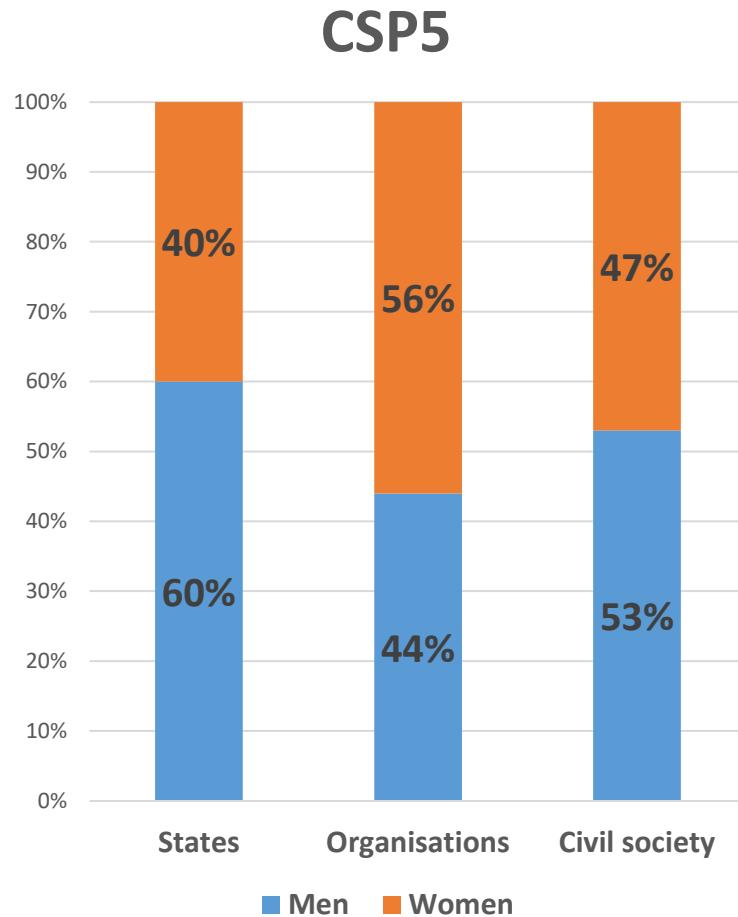
## *Sources of data*

## *Data limitations*

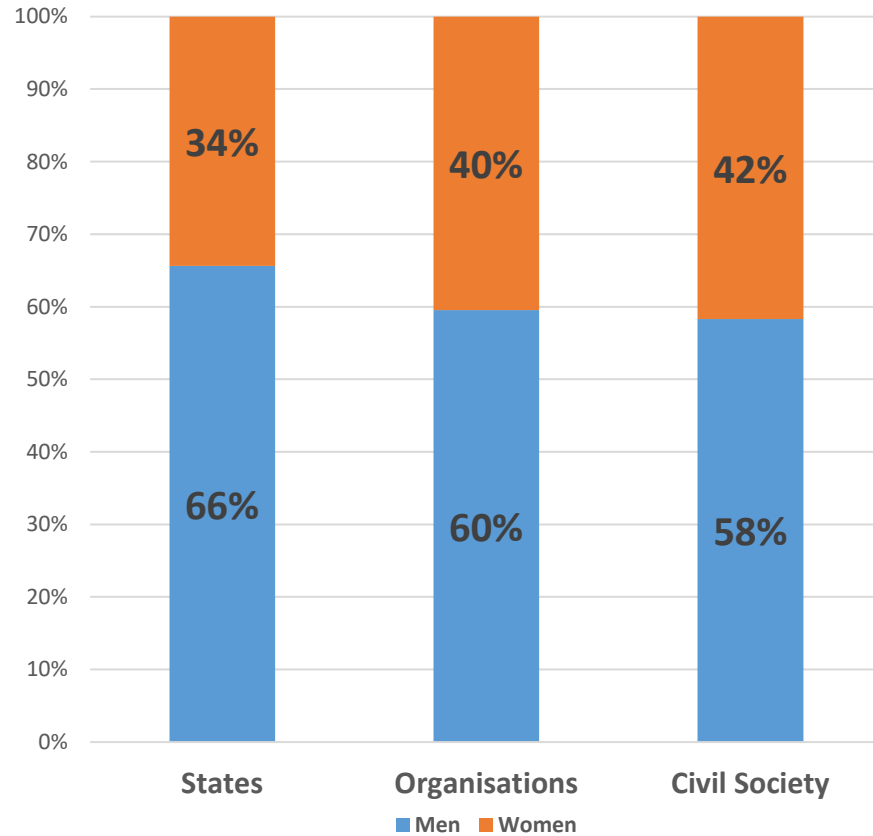
- Migration to new website in 2018

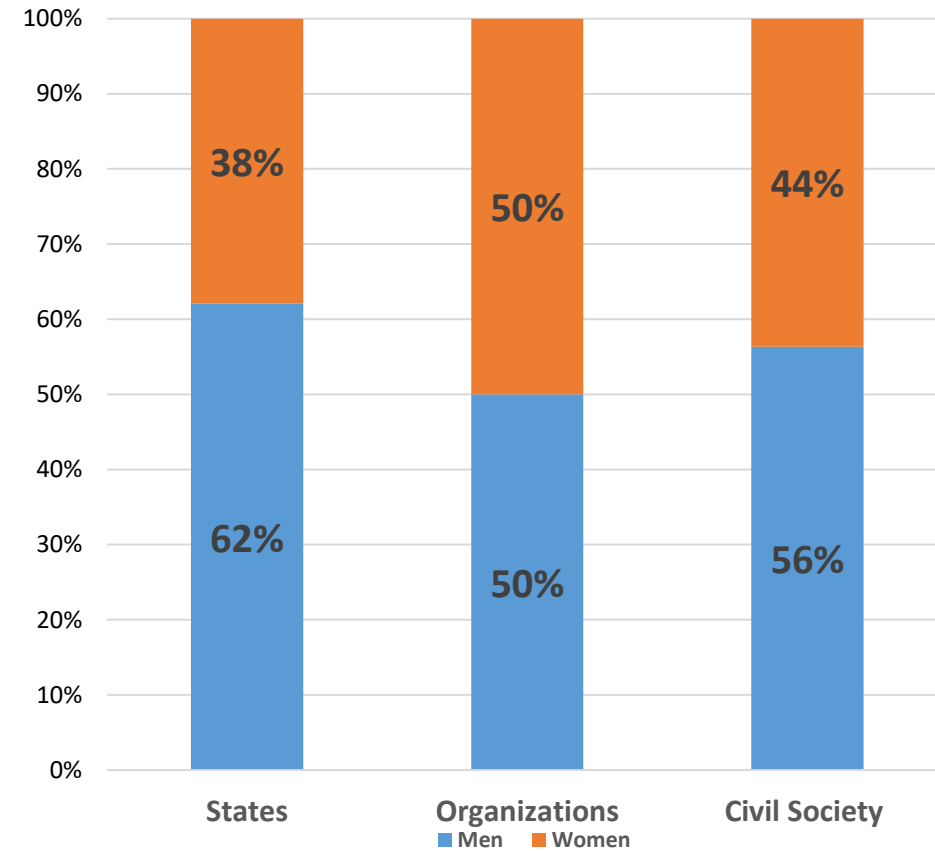

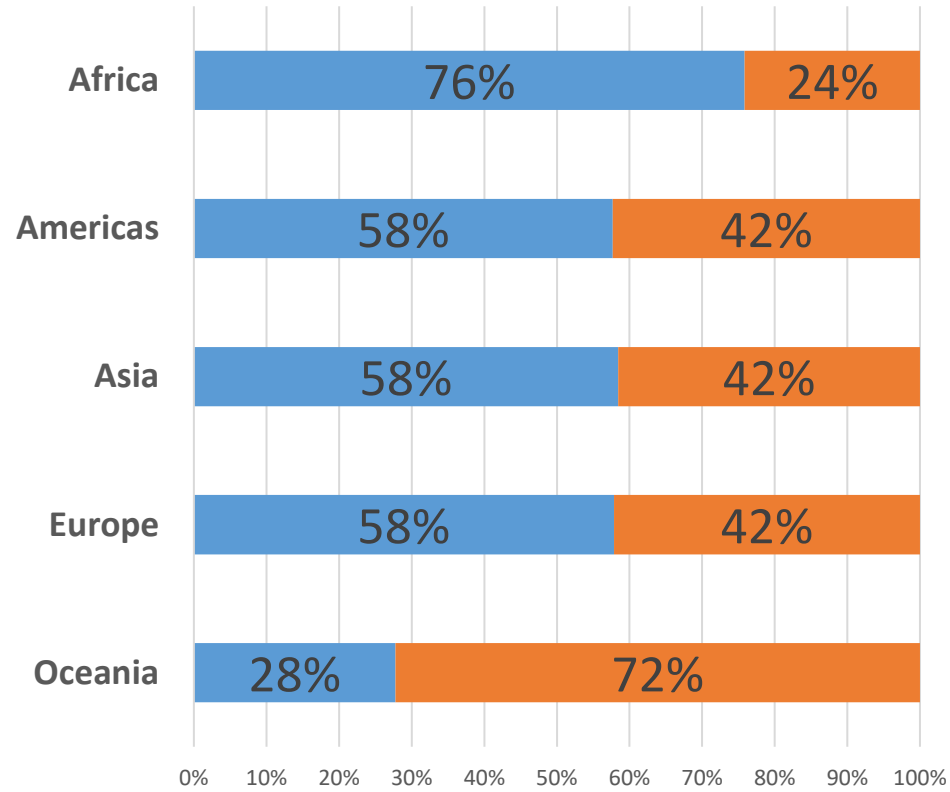

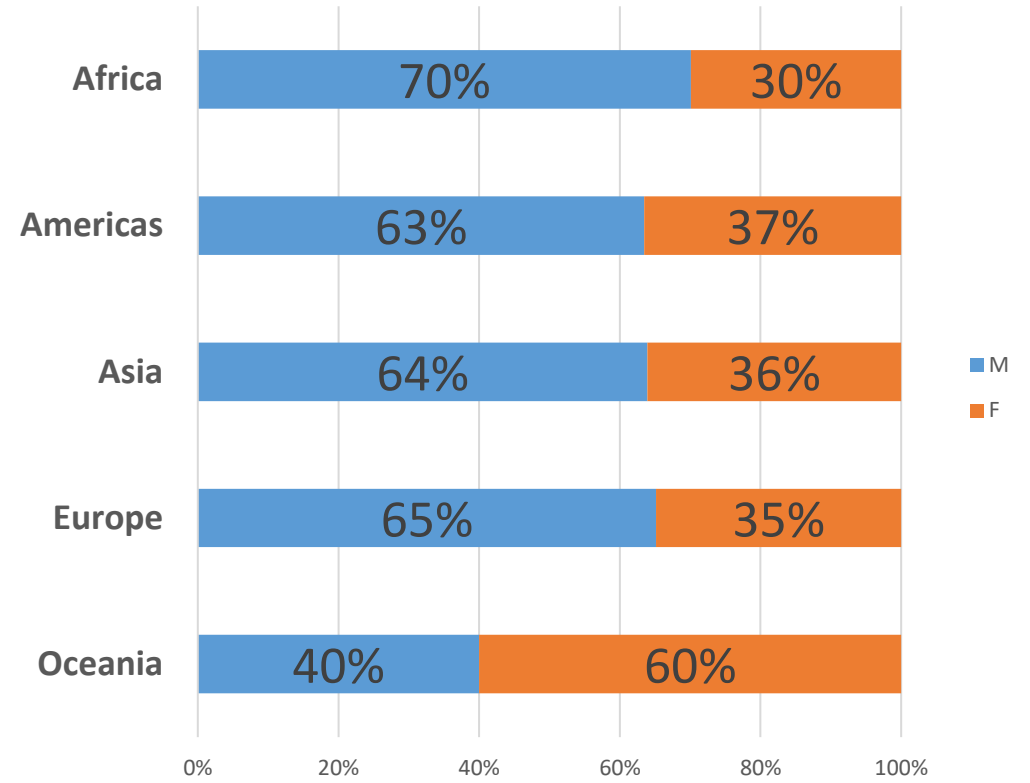
# Gender balance among State delegates

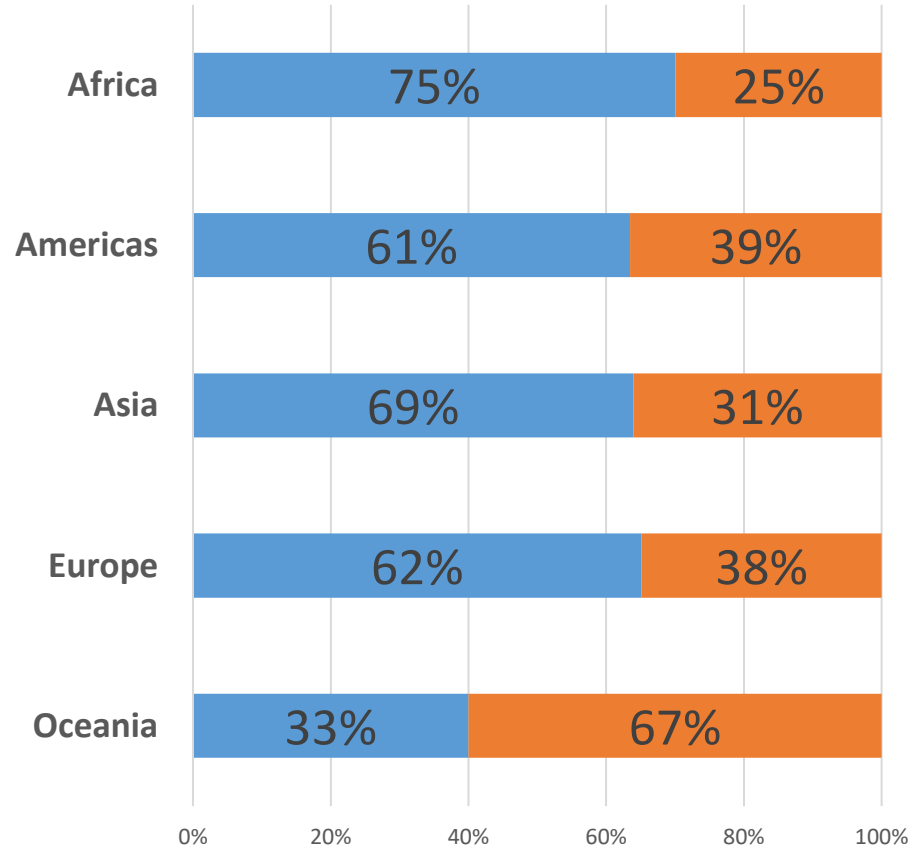

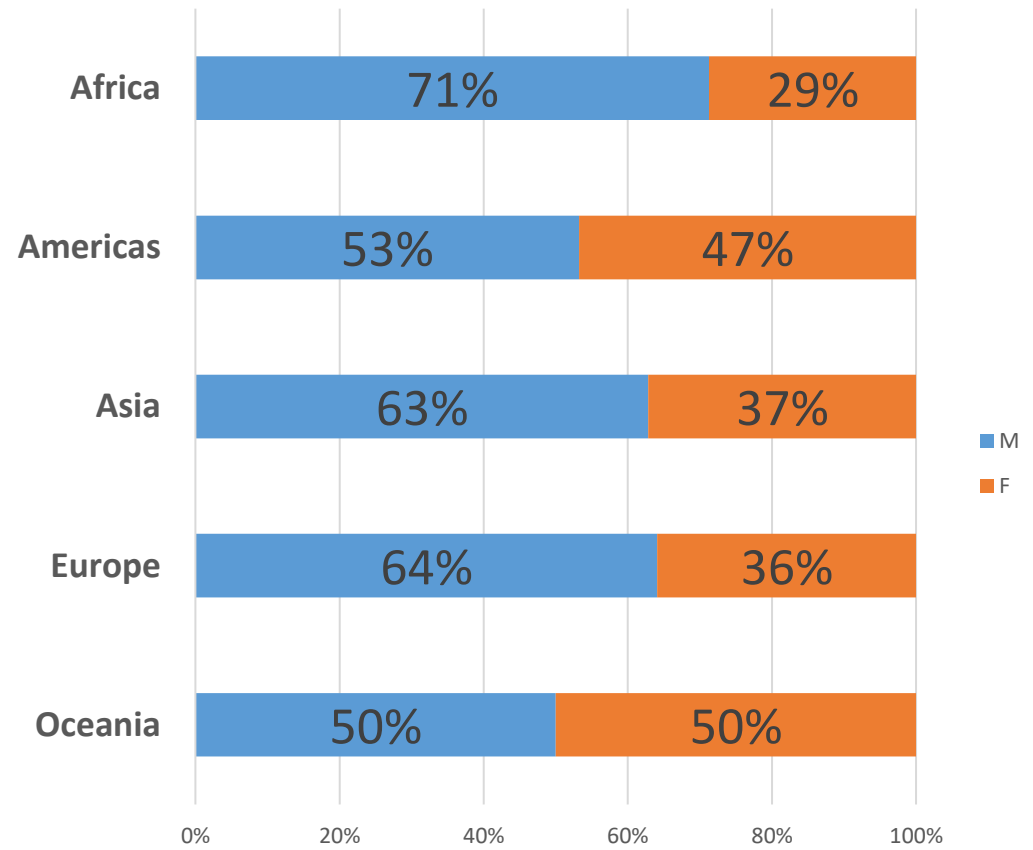

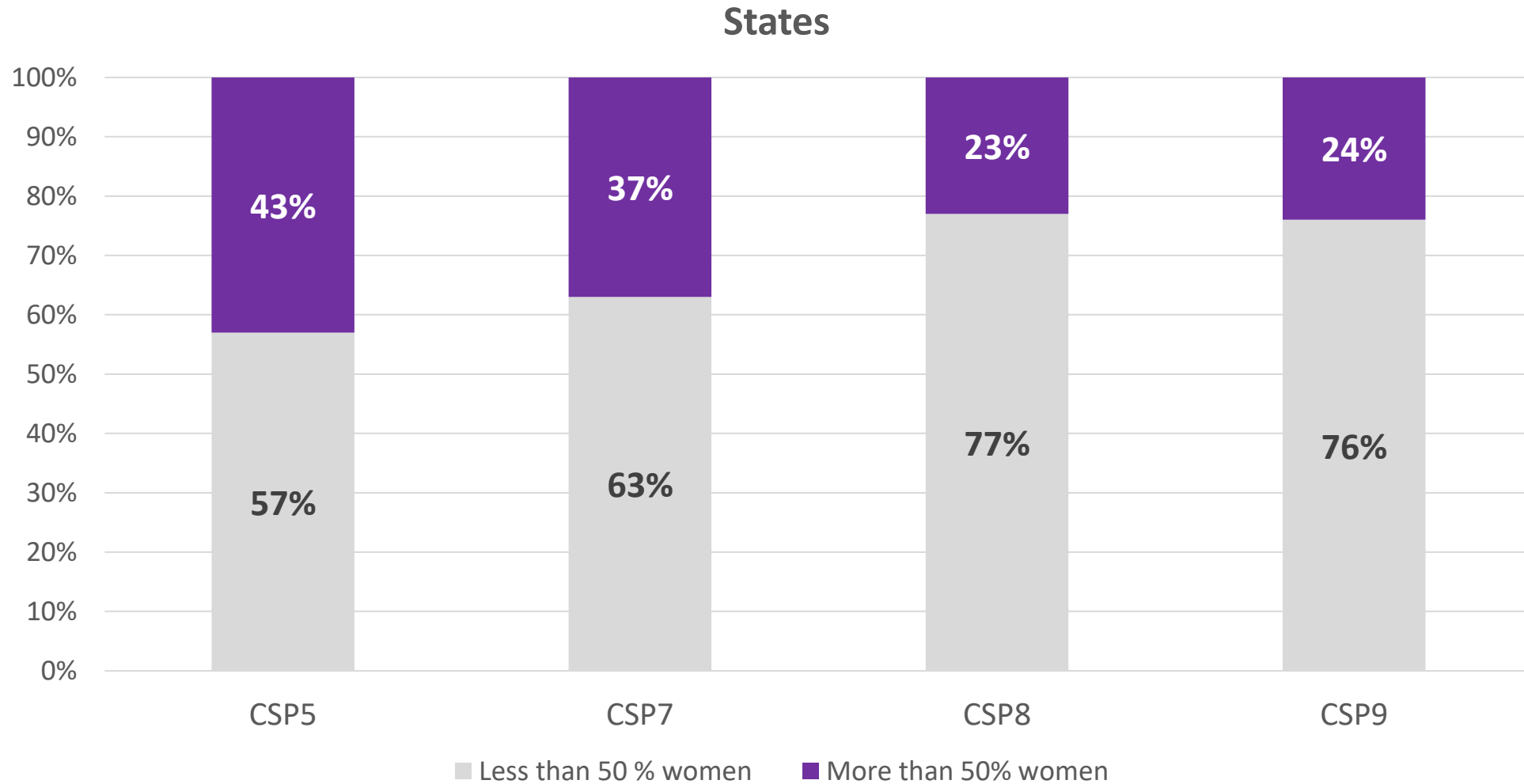

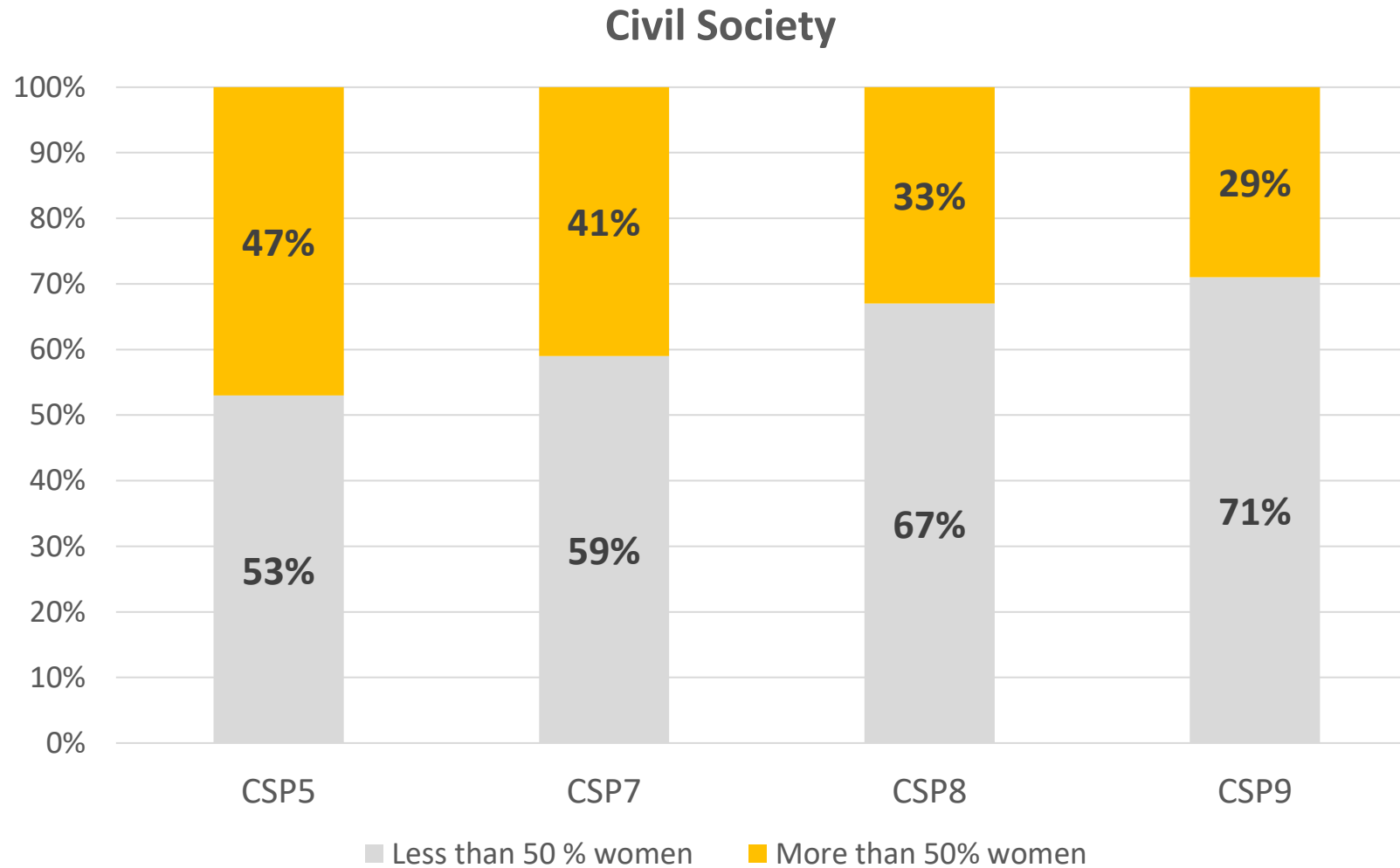


# Participation: by no. of delegations (by %)

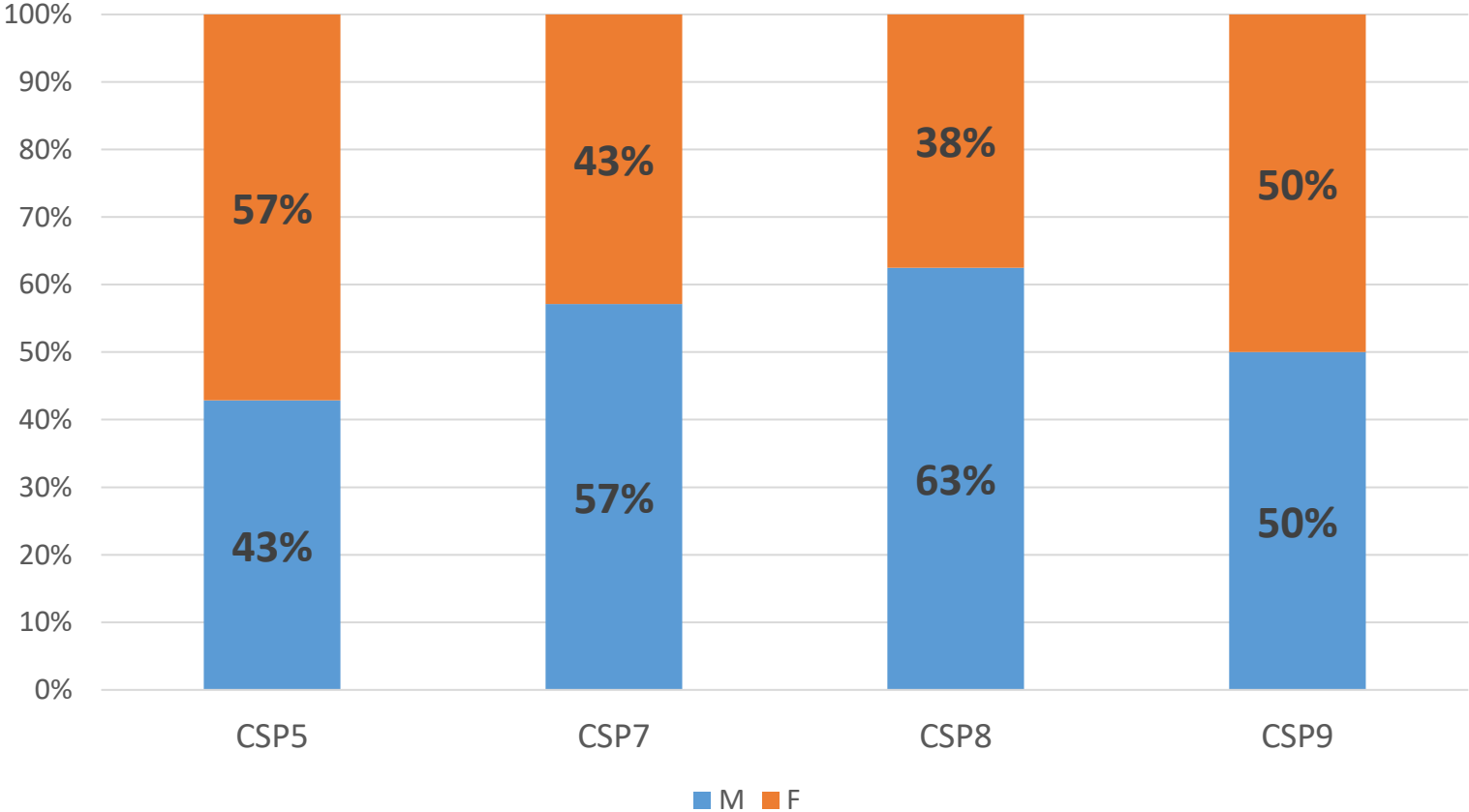

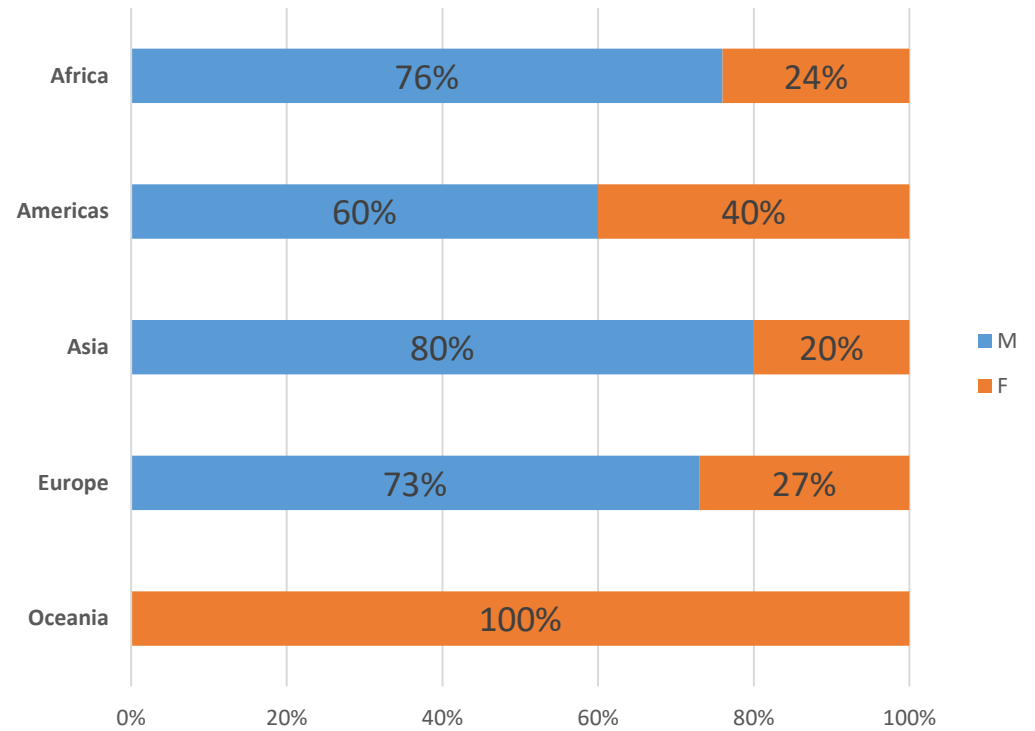
