INVITATION TO THE ATT CSP10 WORKING GROUP MEETINGS: 20 - 23 FEBRUARY 2024

1. The Ninth Conference States Parties (CSP9) to the Arms Trade Treaty held on 21 - 25 August 2023 established an informal preparatory process for the Tenth Conference of States Parties (CSP10). On 20 November 2023, the President issued an announcement regarding the schedule of ATT meetings for the period leading up to CSP10 and the ATT office holders.

2. I have the pleasure to invite you to the meetings of the ATT Working Groups, which will take place over the period 20 - 23 February 2024 at the Centre International de Conférences Genève (CICG), Geneva, Switzerland. Information pertaining to the meetings is outlined below.

3. The meetings of the ATT Working Groups will be held in-person, with an option for those who cannot attend in-person to follow the meetings via livestreaming. The link to follow the meetings via livestreaming will be circulated to all stakeholders and published on the ATT website in advance of the meetings. Daily sessions of the meetings will take place from 10:00 to 13:00 and 15:00 to 18:00 (Geneva time).

Draft schedule of meetings

4. The order and duration of the meetings is reflected in the draft schedule in the attached Annex. The draft schedule is subject to change, as appropriate.

5. Documents for the meetings will be issued by the Chairs of the Working Groups and other ATT office holders through the ATT Secretariat alongside this invitation.

Registration

6. It is brought to your attention that pre-registration will not be required for these meetings. However, representatives of States Parties and Signatory States wishing to participate in the meeting of the Diversion Information Exchange Forum (DIEF) on 22 February 2024 will need to register. Further

details on the administrative arrangements will be shared upon circulation of the documentation for this DIEF meeting.
